Zone Rep Report from Sue Foley

Hi everyone. Firstly a big thanks to Maldon Pony Club for the use of their grounds to host the Zone Show jumping and Dressage qualifiers last December. Thank you also to Section C for hosting the event and to everyone who helped in any way. Special thanks to our admin extraordinaire on the day, Linda Gerring and Debbie Ruff and to Don Roach as always for the great job he does with the scoring.

Best of luck to all our riders' competing at the PCAV State Dressage and Show jumping Championships on February 21st and 22nd. Your clubs and your Zone are proud of you all. January 1st saw the implementation of the rule additions and update to the Handbook of Bylaws, the Dressage Rules, Horse Trials Rules, Show Jumping Rules, Games Rules and, of course, Gear Check Rules. These have all been added to the PCAV website with new rules and amendments highlighted in red.

Everyone involved in pony club should read the rules. At a minimum all pony club committee members need to read the rules. The first thing I would advise clubs to do is print off and laminate a copy of the <u>Gear Check Rules 2015 Quick Reference Guide</u> to have handy at your first rally.

The Coaches registration procedure and process has proven to be as clear to us all as mud in a beer bottle on a dark night. I have spent some time emailing and talking with Clare at head office to clarify it. Firstly, the rationale behind the registration.

Coach Membership - Why do Coaches need to become members of PCAV?Best practice

Pony Club has many officials and personnel who actively represent the organization. Best practice would suggest ensuring you know who these individuals are, what qualifications they hold and be able to communicate with them directly. Most sporting, membership based organisations ask individuals, such as coaches, to become members of the organisation to formalise this association. Membership is a contractual relationship and provides a clear intent to operate on behalf of the organisation under the rules of its operation and to receive benefits as provided by the membership category.

The best method to ensure the accuracy of the registered data is for the individual coach to provide and update the details.

Risk management

As members of the Board of Management of an Incorporated Association, Zone Committees and State Council members have a duty of care to ensure the safety of our members and to adhere to legal requirements. Currently the State Association does not have an accurate record of individuals participating in Pony Club activities as a coach; this is a risk management issue for all levels of governance in Pony Club. Coaches are legally required to hold a WWCC card. One way to manage this risk is to know who is coaching in Pony Club and request proof of undertaking this legal requirement. Clubs and Zone can assist with this risk management process by ensuring all coaches are paid members of the Association and by asking coaches to produce proof of PCAV membership. Coach Membership will streamline this process for Clubs.

Insurance

Pony Club Victoria has a responsibility to members to adequately manage the Association's risk for insurance by understanding the scope of its potential liability. Coach Membership is a formalisation of an existing member group which enables the organisation to better understand the number of coaches operating in Pony Club, which individuals are actively representing the organisation as a coach, their level of qualification and adherence to legal requirements.

Supporting Pony Club

Pony Club Victoria is a not-for-profit organisation which currently depends largely on membership fees and government grants to run its operations, services and programs. Members' money is channelled back into programs and services such as membership management, club official and coach training, NCAS training and accreditation, club development programs, insurance, websites and the magazine.

All of these activities are aimed to create a quality Pony Club experience. Currently our Riding Members are the only membership category who financially supports the running of the organisation. However many services are targeted and made available to support personnel. Membership is a way of supporting an organisation and helping to ensure it can continue to grow and provide its services to all who operate within its ranks. Coach Membership is about asking coaches to assist with supporting the organisation on this level

and being proud to say they are a member of Pony Club. Becoming a Coach Member of Pony Club is a way of supporting our riders and Pony Club's aim to create a fun, enjoyable, challenging and inspiring space for riders to enjoy their horses with their friends. Head office will admit they have learned a lot from the numerous phone calls and emails they have received in regard to the introduction of the registration process. They have listened. Consequently those adult riding members who teach at pony club and also the senior members now register but they don't have to pay a fee.

<u>Coach Membership</u>

Coach membership is moving to a fee base soon. From January 2015 coaches are required to register for membership with the State Body. Coach membership is mandatory. Coaches not registered on the PCAV Database are not considered approved and will not be covered under the PCAV insurance policy. All coaches over the age of 18 must have a Working with Children's Check card. The following Fee Structure will apply:

- \$25 | Non PCA NCAS Qualified/EA Coaches
- \$75 | PCA NCAS Preliminary Coaches
- \$150 | PCA NCAS Level 1 Coaches

A coach/instructor is defined as anyone who receives any sort of payment for teaching at pony club. This means parents/genuine volunteers do not have to register. They do need a WWCC. There must be records kept of volunteers at club rallies.

13.9 Adult Supporter

- 13.9.a An adult supporter is a person aged 18 years or over, who has an interest in the welfare of the club and who is not an associate member of a pony club.
- 13.9.b It is the prerogative of the individual pony club to decide its own policy as to how adult supporter status is achieved.
- 13.9.c -The club must clearly define its policy on adult supporter status and record the policy in the club's minute book, by-laws or rules of incorporation.
- 13.9.d An adult supporter must be financial with the pony club to be eligible for election to the club committee. However, the club may deem adult supporters to be financial without payment of a fee, if the clubs rules permit, in accordance with rule 9.6.b.
- 13.9.e Clubs must record all adult supporters as club members in the club members' register, in accordance with rule 6.6.a.vii, and register them with the PCAV, in accordance with rule 11.

13.10 Service Provider

- 13.10.a A service provider is an instructor/coach who is not a parent or adult supporter in the club in which they are coaching.
- 13.10.b A service provider has no voting rights in a club.
- 13.10.c Clubs must hold a record of all service providers and volunteers at each club activity and register them with PCAV in accordance with Rule 11.

Coaches/instructors who have registered before midnight on December 31st 2014 will need to register again and pay the fee. The fact that they did not get the pay on line Try Booking system live before Christmas has contributed to this confusion. Some Coaches felt that if they registered by December 2014 they were exempt from paying the fee. Others feel it is a "money grabbing" exercise which it is not. The two are mutually exclusive; Coach Membership has been on the table since 2013. This was never the case – it was always going to be a two phase approach – registration then an annual membership fee in line with the calendar year. Calendar year was chosen to help align better with Club activities and programs.

Genuine volunteers do not need to register but clubs must keep accurate records of volunteers for insurance purposes. From January 1st 2015, every DC of a club must sight the coach's ticket before allowing them to teach at a rally, clinic or activity.

Since I presented this report there have been further developments in regard to genuine volunteer coaches. State Council has implemented a process to enable coaches who feel, as

a genuine volunteer, they should not be required to pay a fee to become a Coach Member of PCAV.

A volunteer coach is defined as one who may be qualified or non-qualified and who receives no reimbursement for coaching, time or travel. These coaches can apply to their Club or Zone for volunteer endorsement. The Club/Zone must submit the following details to Kate Wilson at ncas@ponyclubvic.org.au to ensure the coach is registered and approved and therefore covered under the PCAV Insurance Scheme:

- Coaches name
- Club/Zone
- Address
- Email address
- Phone number
- WWCC number and expiry
- Current Qualification

Coach Members who register via this process will be provided with a card indicating that they are registered and approved by PCAV. There is also a new requirement for Working with Children Checks.

Working with Children Check – WWCC

The following motion was passed by State Council at the November 2014 State Council meeting. It is a proactive decision designed to provide a duty of care to all PCAV members. The WWCC Legislation outlines minimum mandated requirements; organisations can broaden their policy and widen the field beyond those listed by The Department of Justice to protect the children/youth in their respective fields. That from July 1st 2015 clubs must ensure that all parents/guardians/carers of members and members over 18 must provide a current WWCC. This motion supersedes Bylaw 8.2.a

A lot of thought and discussion goes into the decisions that are made at State Council. Every decision is made for the long term best interests of the riders, the clubs and the association. State Council are being proactive as an organization and have a duty of care to our riders and to anticipate the risk to the children. The rule for the WWCC is no different to any of the many other rules in the Hand Book of Bylaws. Insurance is put at risk if clubs fail to abide by the rules and all clubs should follow PCAV rules and directives. Litigation will be no different for this than for any other rule that a club does not abide by. A WWCC should form part of a club's risk management to provide a safe environment for its members.

A lot has been happening at the Pony Club Victoria Equestrian Centre. The first event has been held there. This wonderful facility belongs to every member of pony club. It has a beautiful indoor arena, an outdoor arena. It is on 156 acres with the most amazing home that the riders can camp in. The InterZone 3/4 Challenge is to be held there in October. After this all State events will be held at PCVEC so in the not too distant future there will be a Ewan Kellet cross country course up and going! It is all very exciting.

I encourage all clubs of the Midland Zone to consider holding a pony club camp at the venue. There are some stables and yards. Costs will be added to the PCAV website very soon. The facility is available to non-pony club members too so get in early and book your dates!
