Zone Rep Report from Sue Foley

Hi All,

Here we are half way through the year!! The upside is that the warmer weather along with day light saving is getting closer. It is so hard to keep horses fit at this time of year (that is what I hear all the time at my house!).

The first weekend in May saw 14 riders and their support crews from 6 clubs of the Mighty Midland Zone make the trek to PCVEC for the PCV Horse Trials Festival. The festival includes

the State Championships for Grade 1 and 2 riders and the InterZones team challenge for Grade 3 and 4 riders.

It was a fabulous weekend of fun and friendship enjoyed by everyone who participated. Our riders were standouts in their presentation which was commented on by many! They all rode well and did their clubs and their Zone proud. HUGE congratulations to Oscar Cole riding the beautiful Chatswood Tango on winning his section of Grade 2 and also to Riley Perry-Parmenter riding Playing the Field who placed 3rd overall in Grade 1. Every rider in the Midland Zone who is graded from Grade 4 to Grade 1, it's time to start planning for next year to compete at this fantastic event at a beautiful venue.

The new online data base, MyPonyClub now has an app! To find the app, search in your app store for Pony Club Australia. The best news for Pony Club Victoria riders is that PCV State Council recently approved ... "where a member needs to prove they have membership with Pony Club Victoria the virtual membership card on the PonyClub Australia app will be considered valid". To prove grading's and attendance riders will still need their hard copy card.

The Market Research Project conducted earlier this year closed with over 1400 detailed responses received. Members provided a great many detailed comments which meant that the analysis of the data took some time. There is a special State council meeting convened for Tuesday July 31st to discuss the results which will become public after the meeting. PCV has been successful in obtaining a Grant from the Melbourne Racing Club Foundation (MRCF) to support the training & Accreditation of Coaches in the form of scholarships to cover registration and assessment. The grant is available for up to 50 coaches to participate in training for the PCA NCAS Preliminary or Level 1 coaching course. The MRC Pony Club Coach Scholarship Program has been developed to help coaches in Pony Club to undertake formal coach accreditation. These scholarships have been designed with an overarching view to improve the safety and skills of Pony Club coaches working in the field. Funding will apply for the 2018/2019 FY. The application form is on the PCV website.

Pony Club Victoria has announced the appointment of their new Executive Officer to replace Clare Lewin. Rick Gill takes over the reins from Clare on July 16th.

As we are at the start of the new pony club year just a reminder of a few important compliance rules at club admin level. All instructors, coaches and volunteers teaching at pony club rallies, activities, camps and clinics MUST be PCV coach registered for the 2018/2019 year starting from this Sunday.

It is the responsibility of the club DC to sight the current coach registration ticket before allowing an instructor to teach. PCV Insurance specifically states that anyone not following PCAV Rules may be left uninsured and we don't want that.

There is a misunderstanding in the pony club community that because our riders have 24/7 insurance cover that they are automatically covered at rallies and Pony club activities, clinics and competitions. This is not the case as once a pony club committee is responsible for the rally, activity, clinic or competition all pony club rules must be followed and this of course includes the registering of coaches. If the insurance company walks away from a claim the lawyers may come after the committee so PLEASE follow our rules.

In regard to Working with Children's checks, club executive committees need to familiarise themselves with the compliance to this. The child safe standards reinforce this requirement. As well as all instructors needing a WWCC, so do adult supporters including:

- Both parents of riders who regularly attend rallies
- A single parent who regularly attends rallies.
- A non parent guardian of a child either temporary or otherwise who regularly attends rallies.
- An honorary life member who regularly attends rallies and club activities.
- Visiting members and adult supporting members as defined above from clubs other than the host club.
- A non member who does not fall within the categories listed above who regularly attends rallies and club activities.

Regularly is defined as 3 or more rallies per year. It is also vital that all pony club members who have a WWCC have PCV of 73-75 Mackie Road Mulgrave registered with their card. Please don't forget the Zone AGM to be held in St Arnaud on August 3rd. It would be so great to see every club from the Zone represented.
