APPENDIX 2 - Zone Reps report September 15th 2020

Hi All,

It was wonderful to receive the news that regional Victoria moves into stage 3 restictions from 11.59pm tomorrow evening, September 16th. It has been great to see the clubs of the MZ keeping their riders engaged with various activities on Facebook. Thanks also to MZ Chief Instructor Linda Gerring for her efforts to keep the certificate learning happening via the FB certificate and coaches groups

Congratulations must go to the committee and members of Learmonth PC on being granted full club member affiliation to PCV. This is a wonderful achievement in the 12 month time frame. The exec committee has done an outstanding job in getting the club to this point. It is wonderful to have the club as members of the Mighty Midland Zone and we extend them a very warm Midland Zone welcome!

A summary of the business put before State Council at the September meeting is as follows:

□ The CIP recommendation to re-instate D certificate as prerequisite for Horse Trials grading was not supported by State Council

□ Acceptance of the development of National Competition Gear Rules for National Championships was supported

□ Member Categories:

□ State Council has been considering member categories as a means to stimulate membership within clubs with the recommended that a new pre-junior category be established to address the lack of 7 year old's and under within the association.

Suggested New Member Category for members aged 7 and under: Little Tackers

Eligibility: Children aged 7 and under. Eligibility will be optional - Parents can choose for their child to participate as a Junior or as a Little Tacker. Like the Adult Member, Little Tackers will be optional for clubs to offer.

Price: It is recommended that the annual price point be set at 50% of the current Junior Member price for the PCV component (\$76). Clubs are able to charge what they like for this category (as they are for all categories) however it is hoped that in the spirit of the objectives of Little Tackers club costs will also be 50% of regular junior membership.

Program:

To be developed in conjunction with the CIP with advice from Sue Foley from Midland Zone. In principle it will be a reduced hour's program to recognise the attention span and physical limitations of younger riders

There are some clubs already holding limited programs for younger members. There will be some core requirements which will be formed as part of the program development. Clubs will be required to call this membership Little Tackers (or another agreed name) if it is offered. While the name Little Tackers is suggested, this name is only a recommendation. It was suggested that a competition be held to choose a suitable name.

□ Volunteers aged 80 and over.

Pony Club Victoria need to notify our insurance company of any **members/volunteers** who are aged 80+years to ensure they are specifically included under our insurance policy.

Clubs must specifically notify Pony Club Victoria of this individual providing; name, club name, volunteer DOB

The individual needs to be a current member in the association's database

□ PCVEC Sale Update.

The PCVEC sale is expected to be unconditional 14th September.

Zone Reps are strongly encouraged to promote the SGM and AGM to their clubs once the notice of meeting has been sent.

□ Rally attendances

Rally attendances will reduced from 5 for juniors to 2. Associates to remain at 2 effective from September 1st 2020

The name of Associates Member change to Senior Member

The age of Associate (to be termed Senior) Members be increased to 18 and above, with Junior Members under 18 years.

Between October 2020 and March 2021 it will be permissible to record a rally attendance at 2 clubs each month to assist with qualifying for State Championships.

□ Club committees need to be encouraged to hold more than 1 rally per month for a couple of months, if possible to allow value from memberships for time lost, and to be able to record attendances to enable to qualify for State Championships. Clubs should also consider holding a January rally if this is not something that is normally on their calendar.

□ State Games, Flat & Musical Ride Championships:

With the event being held in June and shorter days, State Council resolved to drop the number to games to 8. This should assist with practice. Zone Reps to request feedback from their clubs. Look at quick game and games with similar equipment to shorten the day. Need to push to have teams in especially Musical Ride and teams of 4.

As the GFMR is being held in June, it must be held at a venue with an all weather arena.

□ State Horse Trials Championships and InterZone event

There will need to be an EOI for a venue. HT Committee to make recommendations.

□ OmnisSport data base

Any clubs that have held their 2020 AGM and that have not updated their club contacts on the OmnisSport data base please do so ASAP. Would all members please make sure they have the correct and current email address registered on their profile on the database so that they are receiving all communications from PCV head office and the zone?

□ Governance Update

PLEASE don't forget to register to attend the PCV 2020 AGM & SGM.

You also need to register your voting delegate or appoint a proxy to vote on the Governance changes.

If no-one from your club can attend the AGM which is a Zoom meeting, a proxy can be appointed and the proxy form needs to be completed.
