At the recent SC meeting the ZR from North Eastern zone that has long had the most members of all the Zones told us that she doubted that this would be the case come 2022. NE Zone is a zone that has a huge horse population per area. Many of the riders are competition focused and sadly see PC as another means of competition.

In our Zone pony club has a strong focus on friendship, community, learning and fun as well as competition. It has been wonderful to see the clubs of this zone getting together with their riders and riders from other associations to keep the momentum of pony club going through these very trying times. Well done!

More in the theme of the fun available in pony club, Pony Club Quiz is to be added as a discipline at State level . We had a practise run at the SC meeting and it is fun! There is the opportunity for whole state participation and also international opportunity for competitors including RWH. The PCV Quiz committee will look to adapt some PCA rules to suit our needs.

In my last report I mentioned that no EOI had been put to the board for the hosting of the 2022 State SJ & Dressage Championships. Happily East Gippsland Zone has now thrown their hat into the ring and the event will be held at Sale Showgrounds over the weekend of February 25<sup>th</sup> and 26<sup>th</sup>. I had a look at the showgrounds website and it looks to be a wonderful venue. The program will be out in the very near future for the Zone Qualifying Event which is to be held at Mandurang PC grounds on the second weekend in December

Sadly due to the end of the year closing in quickly and lack of suitable venues in the time frame both the Ride to Time State finals and the Games, Flat and Musical State finals have been cancelled which is so disappointing for all the riders. RVC has decided that the current format of Ride to Time needs to change but there have been no decisions made yet as to what the new format looks like. Watch this space!

The State Tetrathlon Committee has asked that Tetrathlon be included as one of the graded disciplines Grading guidelines will be developed and introduced based on the combinations show jumping ability and the rider's age. Novice classes will be offered for riders who wish to jump 10cm lower than their age group.

There has also been a sub committee formed to discuss with the Victorian Polocrosse Association their proposal to add polocrosse as a recognised discipline in PCV. This is great news! I am a member of that subcommittee and we have the first meeting on Thursday.

The PCA Safety Committee has provided a draft document outlining PCA Minimum Medical Service at Pony club Activities and Events. There will be further information about this before the end of the year but suffice to say that the level of medical mandated for Horse trials for example will see increase of entry fees needed to fund the medical requirements.

Thank you to MZ president Peggy Mills and also to MZ past CI Ken Croser for donating their time and expertise this coming weekend to the Zone "NO COST" Show jump judging and Course Design /Building weekend!! I am sure it will be an invaluable experience for all the attendees. Thank you also to Maryborough PC for the use of the grounds.
