Zone Chief Instructor Report from Nicki Chalmers

Unfortunately, I was unable to attend the last CIP meeting and have not yet received minutes so don't have anything to report from that end.

MZ NCAS training and assessment weekend was held on 16th and 17th April. We had approx. 13 attend the training day and 9 for assessment on the Sunday. The weekend ran relatively smoothly and most workbooks were handed in which was great! Most workbooks have now been corrected.

The 2016 Ride to Time program has begun. The first two qualifiers are now done and dusted. Both qualifiers ended up being held at Bendigo, as unfortunately the track at Avoca was deemed too wet for us to use. The final qualifier, which will determine our state qualifying riders, is to be held on the 30th of July at Bendigo. Given the rainfall we are having this year, having a track with a sand track available is important to ensure that the day can go ahead safely no matter the weather conditions. Entries for this final qualifier are still open and I encourage riders to come along and have a go, even if you are not qualifying to get a taste of what it's all about.

Thanks to Debbie Weir who has updated the certificate page on the zone website for me. The Certificate resource guide, C Certificate Guide, C* & K Certificate Guide, are all now available from the website. She has also added the Dressage Test Submission form and Club Treasurers guide.

As the new financial year is about to begin, clubs need to ensure at their July rallies that they check all coaches have updated their coaching membership for the new year BEFORE the rally begins. If they are unable to produce proof, please ensure that you get them registered before they commence coaching for the day.

The next round of C certificate examinations is coming up very soon. Nominations close on July 8th. If nominations and workbooks are not received by this date they will NOT be accepted as corrections will all take place on one evening by the panel. The ridden examinations will be on 6th/7th August. Please see the zone website for information on the nomination process. Riders who have nominated in the past but did not complete the ridden examination MUST re-submit a nomination form so we know they intend to ride at this round.

C certificate manuals have been purchased for examiners and have been received.

- Zone Flat & SJ event is to be run in Section B in August. Program will be out soon, Natalie Bourke will contact Donald PC about running it at their grounds. Nicki will send the Flat ride test out ASAP so that clubs can start practicing at their rallies this upcoming weekend.
- Thank you to Section C for running a great Games, Flat & Musical Qualifying event in April. The day ran smoothly and was well organised.

General Business:

 Letter from Loddon PC regarding the loan of equipment from their club for the Vic Team Championship held in March 2016 that was returned damaged

Note: This equipment was actually loaned to the Zone for the Dressage & SJ Qualifying event in December. The Zone will reimburse Loddon PC for the damaged equipment

- The Zone received a letter from Peggy Mills regarding how we can possibly get more individual and team entries at the Zone SJ and Flat team event. Peggy suggested that we allow teams to be made up of 3, 4, 5 or 6 riders from any grade, and probably now that there are 6 grades, the best 4 scores to count. That is, a team can consist of PA, PB, PC, PD, PE or PF grade riders, or a mixture of those grades, and not just a team made up of a rider from each Grade. After discussion, it was agreed that each Team will consist of 3 or 4 riders but only the 3 highest scores will count. A team may consist of riders from various or the same grades. Teams must have a minimum of 3 riders. This rule can also apply to the Zone Horse Trials Team section.
- Email from Stawell PC regarding the date of the Zone HT for 2017. Grade 2 riders don't have a great deal of time to qualify for the state event and to be able to do this they need to travel great distances. Stawell PC feels that the rules are a bit tough and would like to see them changed, the Zone agrees with this.

Note: Letter to be sent to PCAV about the possibility of changing the rules, Viv Cole to write the letter and send through to Zone Sec who will forward onto PCAV

- Bealiba PC discussion of Zone club affiliation fee in regards to the \$10 to be given to any national riders – this agenda item was not discussed at this meeting as we ran out of time, it will be added to the agenda for the next meeting
- Proposal to have all entries and payments for State events come directly from the clubs – no individual entries/payments to the Zone/PCAV. Clubs will then be responsible for chasing up any queries that the Zone may have. A discussion was held regarding this matter and all clubs agreed that this was a good idea. Moved By Debbie Ruff, seconded by Kira Chalmers
- Linda is to be reimbursed for travelling to Charlton for the XC course accreditation that was completed on the 11th June. She travelled 240km return, Christine to organise this
- The Dressage & SJ Qualifying event needs to be changed from December to another date due to PCAV running a new event on the same weekend. Sue to approach Castlemaine PC to see if they can change their event from 20th November to 9th October so that the Zone can run their event on this date.
- Discussion about the Grant Funding for Zone clubs with the profits made from the Vic Team Championship - this agenda item was not discussed at this meeting as we ran out of time, it will be added to the agenda for the next meeting
- PCAV will be introducing a new model for club visits and at the moment they
 reimburse Zone Reps/DZI panel 50 cents a kilometre for petrol. As of 1st July they
 will no longer be reimbursing for this. Sue would like to know if the Zone can
 reimburse for club visits up until the time that PCAV implement the changes. Moved

- PCAV survey, all zones are being asked to contribute \$900.00 to pay for the survey to try to get more members into PC. The clubs present at the meeting feel that it is a waste of money.
