Rental periods.

Time of return.

Prompt return of equipment is essential, since the radios may be promised to others. Extensions must be approved 24-hours in advance of the expiration date. Equipment is expected to be returned within 4 days of use to the Midland Zone Representative (or a nominated MZ executive committee member).

Rental Rates.

Insurance. Certificates of insurance are not considered security for the equipment rented. The Renter is solely responsible for all charges directly to Midland Zone Inc. Any losses or damage must be fully paid by the renter including but not limited to:

- Replacement cost of any equipment not returned by due date which is lost or stolen.
- Charges which have not been paid within 30 days of invoice date including repairs replacement of any equipment which is lost, damaged or stolen.

Liability. Midland Zone Inc. is in no way responsible for any liability, claims, costs or expenses arising from the use or possession of this equipment. All parties using the equipment are subject to ACMA rules and regulations, local and state ordinances.

Inoperable equipment. The equipment is offered for inspection and test at the time of rental. Midland Zone PCAV, Inc. must be notified with 24 hours if any equipment fails to operate.

Replacement or Repair. Upon return of damaged equipment, Midland Zone Inc. will make a determination of the extent of damage and required repairs. In determining whether equipment shall be replaced or repaired, the judgment of Midland Zone Inc. shall be conclusive.

- Should Midland Zone Inc. determine that the equipment shall be replaced, the Renter shall be responsible for the cost to replace the same item or the closest comparably-equipped model, at current manufacturer's list prices without deduction for depreciation.
- Damage includes any type of damage caused by misuse, neglect, or any use for which the equipment was not intended. Also included is damage caused by fire or water; attempts to make repairs by the Renter or anyone else other than Midland Zone Inc. installation of parts or accessories, product modification or failure to follow instructions contained in the operator's manual is also considered damage.
- It is forbidden to attach stickers or labels to the radios for identification. other than to replace those supplied with the radios.
- Rental will be charged at full price on damaged equipment until repair or replacement has occurred to the satisfaction of Midland Zone Inc.

Lost, stolen or destroyed equipment. In the event that, after delivery to Renter, any of the equipment is lost, stolen, damaged beyond repair, destroyed or otherwise disappears or is not returned for any reason, you will be responsible for the cost to replace the same item at current manufacturer's list price with no deduction for depreciation. Rental will be charged at full price on such equipment until it is paid for.

Theft. In all instances, immediately report any missing, lost or stolen equipment to Midland Zone Inc. **Purchase price.** Rental payments may not be applied to repair costs, or replacement costs.

Local use only. Equipment is rented under the stipulation that it is to be used at the address as described in this agreement Violation of laws. Renter shall not permit the equipment to be used in violation of any laws or applicable regulations.

Sublease. The Renter may not sublease any part of the equipment without written consent from Midland Zone Inc.

No warranty or guarantee. The equipment rented is provided without warranty or guaranty of any kind, expressed or implied. Midland Zone Inc. disclaims any liability for range and coverage.

Authorized representative. The person signing the invoice and contract certifies that they have read the rental form and these policies; that they are duly authorized to sign such an agreement for the company or organization they represent; and that the execution of this document has been authorized by all necessary officers or owners of the business or organization.

Attorney's fees. If necessary to enforce collection of the amount due under this contract, Renter agrees to pay all collection costs and charges including court costs and attorney's fees plus service or finance charges of 1.5% per month on all balances 30 days or more delinquent.
