Firstly, I would like to thank everyone that attended our Zone AGM in Horsham in August. Thank you to Kylie for organising and providing the fantastic venue. I would like to congratulate and thank the zone committee for committing to the

continued prosperity of our zone for the following 12months. Peggy Mills as President, Julie Gould Vice-President, Kylie Kirk Junior Vice-President, Bronwyn Cuthbertson Secretary, Debbie Weir Treasurer, Jill Marshall Event Secretary, Kylie Janetzki Chief Instructor and Kira Chalmers as Zone Examining Secretary.

I attended an in-person State Council meeting on Saturday 14th September, held at the PCV offices in Mulgrave.

Maree Fellows from the board was present to provide some updates from the board. The board has engaged a specialist regarding rules of incorporation to develop one for zones and one for clubs which can be used in a cut and paste manner to standardise across the state and support clubs who need help with this. However, these will be optional, and clubs may continue to use what they currently have in place. However, if clubs continue to use their own constitution, they must ensure that they align with CAV which has made changes. At this stage, they are only in draft format and more info will be provided in due course.

A child safeguarding policy will be developed specific to PCV which aligns with Victorian Legislation.

PCV will have their own stand at Equitana this year, which will be separate to PCA. This will be manned by members of our board, state council and CIP. They are trying to push membership. It's important for clubs to complete the contact information request from PCV so that they can provide contact details to potential members in their areas.

Positive feedback was reported in regards to Victoria's high numbers of non-riding membership category. There was an overall increase of 29% in the non-riding category for Victoria and PCA is interested in understanding how Victoria has done this. So it is important that clubs continue to follow the rules in regards to coaches and club supporters. Every child should have at least one parent/carer as an active club supporter, or any adult that attends regularly.

Minimum medical standards are currently being reviewed in relation to the department of health standards within Victoria. The PCA standards are above those of the standards within Victoria. At this point in time though, we need to continue to align with those laid out and within the PCA rules.

The PCV website is having a timely review.

The Executive officer position has been advertised through a consultant and there were a number of applicants. Interviews are being held throughout October and it is hoped that there will be an appointment by the AGM in November.

The inclusion of Ready to Ride members and ungraded riders at competitions was discussed. Given the rules around training activities and participation, there was a lack of consistency around the state which we want to make fair and consistent. SC is devising a standardised participation activity which will be the only option that will be allowed. It will include a specified dressage test, and poles on the ground only. And it will be open to any ungraded pony club member – no open riders.

There have been a number of announcements from PCV in the last couple of weeks.

The membership year will return to aligning with the financial year, starting in mid-2025. There will be a 6-month membership period from 1st January to 30th June 2025, Before into the new membership cycle starting on 1st July 2025.

New 6-Month Membership Fees for PCV & PCA have been released along with guidelines to prepare for the new membership year.

To ensure this change will not affect our senior riders who are turning 25 during the transition period, we have put an ageing out exemption in place, for the full year of 2025. This means senior members will still be eligible to enter all events as a senior rider in 2025 calendar year. From January 1st, 2026, your membership category will be amended to the adult rider category.

The final zone meeting for the year will be held on December 10th in Maryborough as a face to face. It would be wonderful for people to get this in their diaries now. December is a busy time, however, it would be great to see as many people as possibly in person to finish of the PC year.
